### SECRETARY REPORT

### OLD BUSINESS

Merchandise—First attempt at new design resulted in excellent clearances.  
We need to ensure that there are drinks available throughout the set up, entire convention, and clean up. Food vendor should have had more food available. There were issues at the hotel. Thank you to everyone that had a hand in making 2025 a very successful convention.

The bill is paid for the website and we are moving forward.

Ryan, Andy, and Tim are working on reinstating our non-profit status.

The government shutdown is restricting our abilities to move forward now. Possibly looking at a 6 month window. Our ability to apply for grants is negatively affected at this time.

The fur sale is set for 2/21/26 at the Krile Auction House in Strasburg, IL. Doors open at 7AM, first hammer drops at 9.
